Track 1: Digital Transformation and Quality Assurance in Higher Education

- Digital transformation in higher education - challenges and opportunities (re-shaping higher education, challenges in implementing strategies, the impact of digital transformation, integrating digital tools in higher education, practices and success stories)
- Quality assurance in the digital age (frameworks, quality in online learning environments, integrating digital technologies into operations)
- Design and delivery of high-quality online courses (best practices, quality assurance strategies, quality improvement tools and techniques)
- Ensuring academic integrity in the digital age (addressing challenges, monitoring solutions, plagiarism detection tools, and promoting a culture of honesty and academic integrity)
- Leverage of learning analytics to improve quality (learning outcome analysis, data-driven insights, ethical and privacy considerations)
- Digital credentials and their quality assurance (accreditation frameworks, verification and recognition),



Track 2: Smart Technology and Artificial Intelligence in Higher Education

- Artificial intelligence in higher education: opportunities and challenges (applications of artificial intelligence in higher education, ethical considerations and challenges, benefits and risks)
- Digital pedagogy and innovative teaching methods using artificial intelligence (digital pedagogy, innovative teaching methods, effective implementation of digital education)
- Data analytics and learning management systems using artificial intelligence (leverage of data analysis, integration of learning management with artificial intelligence tools, practical examples for decision-making)
- Student support services enhanced by artificial intelligence (existing solutions, assistants, robots and teaching systems powered by artificial intelligence, the impact of artificial intelligence on student anticipation and success)
- Ethics, privacy and security in the age of artificial intelligence (ethical considerations, privacy and security measures, policies and regulations to ensure use)



Track 3: The Role of Stakeholders in Enhancing Quality Assurance and Accreditation Processes


Stakeholder participation (industry experts, educators, practitioners, regulators, professional societies, students, etc.) in QA and accreditation processes, promote collaboration, accountability, and continuous improvement. Some notable roles of stakeholders are:


- Developing standards and indicators (developing standards to reflect needs and expectations)
 - Participation in external reviews: experience and perspectives, providing input and observations.
 - Promoting accountability and transparency (monitoring accreditation bodies, reviewing reports and ensuring compliance with applicable standards)
 - Support for continuous improvement (recommendations, resources, and expertise to help organizations enhance quality assurance processes, instructional methodologies, and program outcomes)
 - Quality advocacy (raising awareness about the importance of quality assurance and accreditation, encouraging organizations to maintain strict standards and continually improve their offerings)
 - Influencing policymakers (influencing policy decisions related to quality assurance and accreditation, developing policies, regulations and guidelines)

- Exploring the international dimension of quality assurance and accreditation (trends, challenges, successful cooperation models)
 - Cross-border recognition and transferability of qualifications (best practices, role of conventions, assessment tools and strategies)
 - Internationalization of quality assurance and accreditation processes (international perspectives, the impact of globalization, internationalization strategies, experiences from institutions)
 - Quality assurance in cross-border education (challenges, ensuring standards, developing effective mechanisms)
