OAAA POLICY ON WEBSITE USAGE TERMS AND CONDITIONS

1. Purpose

This policy details the terms and conditions for the provision of information on the Oman Academic Accreditation Authority (OAAA) website and the use of that information by its stakeholders and other interested parties.

2. Scope

This policy applies to OAAA staff preparing information for access via the OAAA website, and the use of that information by its stakeholders and other interested parties.

3. Policy Statement

The OAAA website aims to provide relevant information to its stakeholders and other interested parties. The OAAA has not made nor makes any representation or warranty, expressed or implicit, as to the accuracy or completeness of information contained in the OAAA website. All parties accessing the OAAA website and making use of the information contained on the website must satisfy themselves as to the accuracy and currency of that information. The OAAA disclaims all liability, expressed or implied, arising out of the use of, or inability to use, or in connection with, the information contained in the OAAA website.

The following Terms and Conditions apply:

a. The OAAA will strive to ensure that the information provided is accurate, current and properly authorised to be in the public domain.

- b. The OAAA reserves the right to change the terms and conditions included in this Policy at any time.
- Website users are responsible for regularly reviewing the OAAA's terms and conditions.

The OAAA disclaims all liability, expressed or implied, arising in connection with messages posted to Discussion Boards hosted on this website. The OAAA reserves the right to remove any messages that may be perceived as libelous or offensive, and reserves the right to cancel the registration of any person to an OAAA discussion list at its complete discretion.
